#### **RESOLUTION NO. 224-2024**

DECLARING MUNICIPAL ORDINANCE NO. 2023-005 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE OFFICE OF THE MUNICIPAL MAYOR OF THE LOCAL GOVERNMENT UNIT OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
