RESOLUTION NO. 230-2024

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2024 (GENERAL FUND AND LOCAL ECONOMIC ENTERPRISES) OF SAN QUINTIN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P173,258,040.22, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Annual Budget for Calendar Year 2024 involving total appropriations of P173,258,040.22 which was enacted on November 6, 2023 through Appropriation Ordinance Nos. 6 and 7, both Series of 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020;

2. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A No. 10121 known as the as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management - National Disaster Risk Reduction and Management Council - Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund;
3. That all procurements to be undertaken shall be in accordance with the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act.) and its revised Implementing Rules and Regulations;
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
5. That the grant of step increment to some municipal officials and employees shall be subject to the provisions of Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 1, S. 2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S.2016 dated January 17, 2016. The appropriation for salaries of the following employees should therefore be adjusted as indicated in Annex "A" hereof;
6. The LGU failed to provide the annual appropriations for Discretionary purposes in the amount of Php 34,163.07 or equivalent to two percent (2%) of the actual receipts derived from basic real property tax in the next proceeding calendar year pursuant to Section 325 (h) of the LGC; and
7. That the following position title should be amended to conform with the Local Budget Circular No. 137 dated July 13, 2021 (Index of Occupational Services, Position Titles & Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition:


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;


