RESOLUTION NO. 24-2024

DECLARING ORDINANCE NO. 080-2023 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING AND IMPLEMENTING REPUBLIC ACT NO. 9418 OR THE VOLUNTEER ACT OF 2007 PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 080-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 34 of R. A. No. 7160; Republic Act No. 9418, otherwise known as the Volunteer Act of 2007; and the Department of Interior and Local Government Memorandum Circular No. 2013-27, entitled “ Volunteer and Citizenship Program”;

WHEREAS, the Local Government Unit should specify the account so as not to affect appropriation already allocated to specific programs;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


