PROVINCIAL RESOLUTION NO. 245-2024

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH DR. SHELDON STEVEN C. AQUINO RELATIVE TO HIS SERVICE AS VISITING CLINICAL AND ANATOMICAL PATHOLOGIST FOR THE PROVINCIAL WATER BACTERIOLOGICAL LABORATORY LOCATED AT THE LINGAYEN DISTRICT HOSPITAL

WHEREAS, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, is in need of the services of a Clinical and Anatomical Pathologist for its Provincial Water Bacteriological Laboratory;

WHEREAS, Dr. Sheldon Steven C. Aquino, who has signified his intention to provide the services needed by the Lingayen District Hospital, possesses the education, qualifications, experience and skills required to perform the services of a Clinical and Anatomical Pathologist;

WHEREAS, Dr. Sheldon Steven C. Aquino shall serve as the Visiting Pathologist of the Lingayen District Hospital from January 1, 2024 to December 31, 2025 unless earlier revoked in writing;

WHEREAS, Dr. Sheldon Steven C. Aquino shall perform work scheduled every first Monday of the month and as the need arises;

WHEREAS, Department of Health Administrative Order No. 172, S-2021, entitled "Policies and Guidelines on the Private Practice of Medical and Paramedical Professionals in Government Health Facilities" encourages the employment of physicians and paramedical personnel who are experts in their field of practice in various government hospitals and other government health facilities;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Honorable Governor, Ramon V. Guico III, and Dr. Sheldon Steven C. Aquino;

NOW, THEREFORE, on motion of SP Members Shiela Marie F. Baniqued and Jerry Agerico B. Rosario, duly seconded, it was –


