APPROVING SB RESOLUTION NO. 93, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 FY 2023 AMOUNTING TO EIGHT MILLION EIGHT HUNDRED FIFTY-TWO THOUSAND PESOS (P8,852,000.00) FUNDED BY THE GENERAL FUND FY 2023 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 93, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.5 for FY 2023. This was endorsed to the Sangguniang Bayan for approval on December 14, 2023 by the Municipal Development Council through Resolution No. 2023-11;
- 2. Said SIP covers fund augmentation for Personal Services (Granting of Service Recognition Incentive and Collective Negotiation Agreement Incentive to Qualified Employees), Maintenance and Other Operating Expenses of some municipal government offices, and the implementation of disaster risk reduction management programs/projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP8,852,000.00 is embodied in their proposed Supplemental Budget No. 5 for Fiscal Year 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 06-S.2023 on December 15, 2023 and approved by the Municipal Mayor on December 19, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 93, S-2023 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving Supplemental Annual Investment Program No. 05 FY 2023 amounting to Eight Million Eight Hundred Fifty-Two Thousand Pesos (P8,852,000.00) funded by the General Fund FY 2023 of the Municipality of Bani, Pangasinan";
