RESOLUTION NO. 25-2024

DECLARING ORDINANCE NO. 081-2023 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS OFFICES AND PLANTILLA POSITIONS IN THE EXECUTIVE DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF LABRADOR, DEFINING THE DUTIES AND RESPONSIBILITIES AND PROVIDING THE NECESSARY FUNDS THEREOF AND ABOLISHING THE PLANTILLA POSITIONS OF ADMINISTRATIVE OFFICER V AND MANPOWER DEVELOPMENT OFFICER I" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 081-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
