APPROVING RESOLUTION NO. 257, S-2023 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 04, SERIES OF 2023, ENTITLED: RESOLUTION RECOMMENDING THE RE-ALIGNMENT NO. 1 OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (MDRRMFIP) CY 2023 AMOUNTING TO FIVE MILLION SIX HUNDRED THOUSAND PESOS (P5,600,000.00) (SIC)”

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 257, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Disaster Risk Reduction and Management Council of Binmaley, Pangasinan proposed to the Sangguniang Bayan the realignment of the sum of ₱5,600,000.00 from the 5% Municipal Disaster Risk Reduction and Management Fund of the LGU. This was endorsed by the Council, through MDRRM Council Resolution No. 04, Series of 2023 dated November 21, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991; and

2. The new projects proposed (Purchase of Rescue Ambulance Vehicle, Rescue Pick Up and ATV) to be funded from the 5% MRDDM Fund conform with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). It is, however, recommended that following the approval of the proposed realignment or this subject Resolution, said project shall be integrated in the Supplemental Investment Plan/Program, endorsed by the Local Development Council and approved by the Local Sanggunian.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


