RESOLUTION NO. 254-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF BINMALEY, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P4,527,400.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of P4,527,400.00, which was enacted on December 21, 2023 through Appropriation Ordinance No. 3, Series of 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings);

- 3. That the grant of Representation and Transportation Allowances to municipal officials shall be in accordance with the provisions of Local Budget Circular No. 103 of the Department of Budget and Management dated May 15, 2013;
- 4. That the grant of Service Recognition Incentive (SRI) to municipal officials, regular and casual employees shall be in accordance with the provisions of Budget Circular No. 2023 2 of the Department of Budget and Management dated December 13, 2023; and
- 5. That the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in the municipality for FY 2023 shall be in accordance with Budget Circular No. 2023 3 dated December 14, 2023.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 2 for Calendar Year 2023 of Binmaley, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Binmaley, Pangasinan, for its information and guidance.
