RESOLUTION NO. 257-2024

DECLARING MUNICIPAL ORDINANCE NO. 11, S-2023 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “AN ORDINANCE CREATING TWO (2) PLANTILLA POSITIONS OF ADMINISTRATIVE AIDE IV (BOOKBINDER II), SG 4, UNDER THE EXECUTIVE BRANCH OF THE LOCAL GOVERNMENT UNIT OF BINMALEY, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 11, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 11, S-2023 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled “An Ordinance creating two (2) plantilla positions of Administrative Aide IV (Bookbinder II), SG 4, under the Executive Branch of the Local Government Unit of Binmaley, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
