RESOLUTION NO. 26-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-09 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2023-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 16 of R. A. No. 7160; 1987 Philippine Constitution; Article II Section 21 of the Constitution’s Declaration of Principles and State Policies; Proclamation No. 62 dated September 30, 1992; Executive Order No. 319, entitled “ Institutionalizing the Moral Recovery Program (MRP) in All Government Departments, Offices, Agencies and Government-Owned and Controlled Corporations Through the Establishment of Integrity Circles;

WHEREAS, the Local Chief Executive in coordination with the Municipal Local Finance Committee shall provide an appropriation in the preparation of the Annual Budget for the ensuing fiscal year for the implementation of the subject ordinance;
