#### **RESOLUTION NO. 260-2024**

DECLARING MUNICIPAL ORDINANCE NO. 14, S-2023 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE III (DRIVER I) UNDER THE OFFICES OF THE LEGISLATIVE DEPARTMENT OF THE MUNICIPALITY OF BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 14, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R.A. No. 7160:

WHEREAS, the educational attainment of Administrative Aide III (Driver) should be amended from High School Graduate to Elementary School Graduate to conform with the Qualification Standard issued by the Civil Service Commission;
