APPROVING SB RESOLUTION NO. 164-2023 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 003-2023 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 164-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 03, CY 2023 of the LGU. This was endorsed by the Council, through MDC Resolution No. 04-2023, Series of 2023 dated November 24, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has a total investment requirement of ₱16,403,000.00, covers the augmentation of funds for Personal Services (granting of Collective Negotiation Agreement Incentives to qualified municipal employees), Maintenance and Other Operating and Capital Outlay of the LGU, and the implementation of other priority projects of the municipality; and

3. Funding for the full implementation of this Supplemental AIP is embodied in their Supplemental Budget No. 03, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 003-2023, dated December 11, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Malasiqui, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. No. 164-2023 of the Sangguniang Bayan of Malasiqui, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 003-2023 of the Municipality of Malasiqui, Pangasinan";
