#### **RESOLUTION NO. 263-2024**

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2023 OF MALASIQUI, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P16,403,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of P16,403,000.00, which was enacted on December 11, 2023 through Appropriation Ordinance No. 003-2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the appropriation for Collective Negotiation Agreement (CNA) Incentive for CY 2023 to municipal employees shall be subject to the provisions of Budget Circular No. 2023-1 of the Department of Budget & Management dated November 10, 2023;
- 2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;

- 3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007; and
- 4. That the reversion of savings shall be in accordance with the provisions of Section 336 of R. A. No. 7160 (Use of Appropriated Fund & & Savings).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2023 of Malasiqui, Pangasinan;
