RESOLUTION NO. 27-2024

DECLARING MUNICIPAL ORDINANCE NO. 2023-10 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF ALCALA, PANGASINAN, REPRESENTED BY HON. JOJO B. CALLEJO, AND THE LAND BANK OF THE PHILIPPINES (LANDBANK), REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, CESAR N. ULPINDO, IN THE AMOUNT NOT EXCEEDING SIXTEEN MILLION PESOS ONLY (P16,000,000.00) TO FUND THE ACQUISITION OF LOT AS SITE FOR THE CONSTRUCTION OF COMMUNITY HOSPITAL, INCLUDED IN THE APPROVED ANNUAL/SUPPLEMENTAL INVESTMENT PROGRAM FOR CY 2023" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Ordinance No. 2023-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Provincial Planning and Development Coordinator have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297 (a), 444 (1) (vi) and 447 (a) (2) (iii) & (iv) of R.A. No. 7160;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-10 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipal Government of Alcala, Pangasinan, represented by Hon. Jojo B. Callejo, and the Land Bank of the Philippines (Landbank), represented by its Assistant Vice President/Head, Pangasinan Lending Center, Cesar N. Ulpindo, in the amount not exceeding Sixteen Million Pesos Only (P16,000,000.00) to fund the acquisition of lot as site for the construction of community hospital, included in the approved Annual/Supplemental Investment Program for CY 2023” as within the conferred powers of the Sangguniang Bayan to enact;
