APPROVING RESOLUTION NO. 205, S-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PLAN NO. 06, CALENDAR YEAR 2023 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its SB Resolution No. 205, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of Rosales, Pangasinan has identified items in their Supplemental Investment Program No. 06 for CY 2023. This was endorsed to the Sangguniang Bayan on December 28, 2023 through MDC Resolution No.1229, S. 2023;
2. The SIP No. 06 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to qualified municipal employees of LGU Rosales); and

3. Funding support for the proposed SIP, with a total investment requirement of PhP2,926,000.00 is embodied in the municipality's Supplemental Budget No. 06 which was approved and enacted through Appropriation Ordinance No. 07-2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;


