RESOLUTION NO. 278-2024

DECLARING ORDINANCE NO. 07-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PRIVILEGES, BENEFITS, PROGRAMS AND SERVICES FOR SOLO PARENTS AND THEIR CHILDREN, IN THE MUNICIPALITY OF ROSALES, PANGASINAN AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 07-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Provincial Social Welfare and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv), 447 (a) (5) (xiv) of R. A. No. 7160; Republic Act No. 8972, otherwise known as the "Solo Parents Welfare Act of 2000" and Republic Act No. 11861 or the Expanded Solo Parents Welfare Act;

WHEREAS, the Sangguniang Bayan shall incorporate the recommendations of the Provincial Social Welfare and Development Officer stated in her opinion dated January 30, 2024;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
