## PROVINCIAL ORDINANCE NO. 288-2022

AN ORDINANCE ABOLISHING VACANT POSITIONS IN THE OFFICE OF THE PROVINCIAL GOVERNOR UNDER THE SPORTS DEVELOPMENT OFFICE

WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

**WHEREAS**, such power to create carries with it the power to abolish positions if it deems necessary;

**WHEREAS,** five positions in the Office of the Governor under the Sports Development Office are left vacant;

**NOW THEREFORE,** on motion of SP Members Vici M. Ventanilla and Jerry Agerico B. Rosario, duly seconded -

Be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

**SECTION 1. Title.** – This ordinance shall be known as "An Ordinance abolishing vacant positions in the Office of the Provincial Governor under the Sports Development Office."

**SECTION 2. Abolition**. – The following vacant positions in the Office of the Provincial Governor under the Sports Development Office are hereby abolished:

**SECTION 3. Utilization of the Appropriated Funds**. – The appropriation for the salaries and benefits of the abolished positions shall be utilized for the salaries and benefits of other positions that will be created under the Provincial Community Development and Training Office.

**SECTION 4. Separability Clause** – If any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which shall not be affected shall continue to be in full force and effect.

**SECTION 5. Repealing Clause** – All ordinances and administrative circulars and executive orders or parts thereof which shall be found to be inconsistent with provisions of this Ordinance shall hereby be repealed and amended accordingly.

**SECTION 6.** Effectivity. This ordinance shall take effect upon approval.
