**APPROVING RESOLUTION NO. 2023-190 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 5, C.Y. 2023 OF SUAL, PANGASINAN AMOUNTING TO THIRTY-ONE MILLION FOUR HUNDRED FORTY-SEVEN THOUSAND SEVEN HUNDRED TEN PESOS (P31,447,710.00)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2023-190 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.5 for CY 2023. This was endorsed to the Sangguniang Bayan for approval on November 6, 2023 by the Municipal Development Council thru Resolution No. 7, Series of 2023;
2. The SIP No. 5 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses of some municipal offices, and implementation of disaster risk reduction and management programs/projects of the LGU; and

Funding support for the implementation of the same in the amount of PhP31,447,710.00 is embodied in their proposed Supplemental Budget No. 05 CY 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 06, CY 2023 on November 20, 2023 and approved by the Municipal Mayor on December 5, 2023.


