RESOLUTION NO. 29-2024

DECLARING ORDINANCE NO. 15, S-2023 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE OFFICER V, (BUDGET OFFICER III) SALARY GRADE 18 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 15, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. 7160;

WHEREAS, the Local Chief Executive in coordination with the Municipal Local Finance Committee shall prepare a supplemental appropriation (supplemental budget) to implement the subject ordinance;


