PROVINCIAL ORDINANCE NO. 292-2023

AN ORDINANCE RETITLING A PLANTILLA POSITION IN THE OFFICE OF THE SANGGUNIANG PANLALAWIGAN IN THE PROVINCIAL GOVERNMENT

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the position and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, DBM Local Budget Circular No. 137, dated July 13, 2021, contains an updated list of classes or position titles in the existing local government units prescribing that all positions shall be allocated to their proper position titles;

WHEREAS, in pursuance to the aforesaid Circular, there is a need to retitle the position of Legislative Staff Employee II to Local Legislative Staff Employee II of the Office of the Sangguniang Panlalawigan;

WHEREAS, the retitling of the said plantilla position also conforms with the approved Plantilla of Personnel as indicated in the Index of Operational Services (IOS), Position Titles and Salary Grades;

WHEREAS, the Sangguniang Panlalawigan finds it meritorious to retitle a plantilla position in order that the office concerned could deliver more effective and efficient duties and responsibilities;

NOW, THEREFORE, on joint motion of SP Member Vici M. Ventanilla, Chairman of the Committee on Appropriations, and SP Member Jerry Agerico B. Rosario, Chairman of Human Resources and Development, Labor and Employment Concerns, duly seconded,




