RESOLUTION NO. 292-2024

DECLARING ORDINANCE NO. 2024-01 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AMENDING SECTION 4 SUBPARAGRAPH 13 OF MUNICIPAL ORDINANCE NO. 2021-07 SPECIFICALLY THE QUALIFICATION STANDARDS FOR SOCIAL WELFARE OFFICER I POSITION TO CONFORM WITH CSC RESOLUTION NO. 98-0575 AND CSC MEMORANDUM CIRCULAR NO. 10, SERIES OF 1998” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2024-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the province have conducted initial review and study on said municipal ordinance and found out that the same was in compliance with Civil Service Commission Memorandum Circular No. 10, Series of 1998 re: Amendment of the Qualification Standard of the Positions of Social Worker Officer I-V;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-01 of the Sangguniang Bayan of Bugallon, Pangasinan, entitled “Amending Section 4 Subparagraph 13 of Municipal Ordinance No. 2021-07 specifically the Qualification Standards for Social Welfare Officer I position to conform with CSC Resolution No. 98-0575 and CSC Memorandum Circular No. 10, Series of 1998” as within the conferred powers of the Sangguniang Bayan to enact;


