PROVINCIAL ORDINANCE NO. 297-2023

AN ORDINANCE AMENDING PROVINCIAL TAX ORDINANCE NO. 1-2022 PARTICULARLY SECTION 38 THEREOF BY CHANGING THE ROAD MAINTENANCE FEE IMPOSED UNDER OTHER FEES

WHEREAS, Provincial Tax Ordinance No. 1-2022, known as the 2022 Revenue Code of the Province of Pangasinan, was approved by the Sangguniang Panlalawigan on December 20, 2022;

WHEREAS, Section 38 thereof provides for the imposition of Other Fees for hauling trucks under extraction fee and road maintenance fee per cubic meter capacity and per truck type;

WHEREAS, the Provincial Government of Pangasinan deemed it necessary to change the imposition of road maintenance fee of P50.00 and P30.00, respectively, per cubic meter capacity thereof, in consideration of the appeal and clamor of operators engaged in quarrying activities;

WHEREAS, the amendment to change the imposition of road maintenance fee with flat rate per truck load will lessen the rate being imposed by the Province pursuant to Provincial Tax Ordinance No. 1-2022;

WHEREAS, the power of the Sanggunian to enact and approve ordinances and resolutions carries with it the power to amend, revoke, modify or repeal the same;

NOW, THEREFORE, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was-

Be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

SECTION 1. TITLE – This Ordinance shall be known as “An Ordinance Amending Provincial Tax Ordinance No. 1-2022 particularly Section 38 thereof by changing the Other Fees imposed under Road Maintenance Fee;



SECTION 2. The amendment shall be as follows:


	Load Capacity (cu.m.)	Extraction Fee/cu.m. (pesos)	Road Maintenance Fee per truck load (pesos)
1. Hauling trucks with 13 cu.m. and above capacity			
- 10-wheeler (Japan)	16 cu.m.	50.00	300.00
- 10-wheeler (China)	20 cu.m.	50.00	300.00
2. Hauling trucks between 6 cu.m. to 13 cu.m. capacity			
- Forward truck	6 cu.m.	50.00	200.00
3. Hauling trucks/vehicle with less than 6 cu.m. capacity			
- Elf truck	3 cu.m.	50.00	100.00

SECTION 3. EFFECTIVITY. This ordinance shall take effect after compliance with legal requirements under the Local Government Code of 1991.


