PROVINCIAL ORDINANCE NO. 304-2023

AN ORDINANCE AMENDING PROVINCIAL TAX ORDINANCE NO. 1-2022 PARTICULARLY SECTION 39 (B) AND (F) THEREOF UNDER SPECIFIC ADMINISTRATIVE PROVISIONS

WHEREAS, Provincial Tax Ordinance No. 1-2022, known as the 2022 Revenue Code of the Province of Pangasinan, was approved by the Sangguniang Panlalawigan on December 20, 2022;

WHEREAS, Section 39 (b) thereof provides that “Loading and extraction of quarry materials shall be made only between 6:00 am to 5:00 pm from Mondays to Sundays;”

WHEREAS, Section 39 (f) also provides that “Permit holders shall faithfully comply with the provisions of the Permit respecting the submission of a report on their daily volume of extraction every 5th day of the succeeding month, specifying therein the kind and quantity of materials extracted, the amount of fees paid therefore, and other circumstances as stated in the Permit. x x x;”

WHEREAS, the Sangguniang Panlalawigan deemed it proper to amend Section 39 (b) of the said Tax Ordinance by deleting the words “only between 6:00 am to 5:00 pm” between the words *made* and *from* and insert the words **any time of the day** in order to allow quarry operators to load and extract quarry materials on a 24-hour basis since the mega projects that would be implemented by the Province of Pangasinan could increase the demand for aggregates over the years;

WHEREAS, likewise, under Section 39 (f) there is a need to insert the word “working” between the words 5th and **day** to emphasize that the date of submission shall fall on a working day;

WHEREAS, the power of the Sanggunian to enact and approve ordinances and resolutions carries with it the power to amend, revoke, modify or repeal the same;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was-

Be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

SECTION 1. TITLE – This Ordinance shall be known as “An Ordinance Amending Provincial Tax Ordinance No. 1-2022 particularly Section 39 (b) and (f) thereof under Specific Administrative Provisions.

SECTION 2. The amendment for Section 39 (b) shall be as follows:


Section 39 (b) thereof provides that “Loading and extraction of quarry materials shall be made any time of the day from Mondays to Sundays;”

SECTION 3. The amendment for Section 39 (f) shall be as follows:


“Permit holders shall faithfully comply with the provisions of the Permit respecting the submission of a report on their daily volume of extraction every 5th working day of the succeeding month, specifying therein the kind and quantity of materials extracted, the amount of fees paid therefore, and other circumstances as stated in the Permit. x x x”

SECTION 4. EFFECTIVITY. This ordinance shall take effect upon approval.


