

PROVINCIAL ORDINANCE NO.320-2024

AN ORDINANCE ABOLISHING A VACANT POSITION AND CREATING A NEW POSITION IN THE OFFICE OF THE PROVINCIAL GOVERNMENT-ENVIRONMENT AND NATURAL RESOURCES OFFICE (PG-ENRO)

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, the Committee on Human Resources and Development, Labor and Employment Concerns, after a study of the proposed organization of the provincial government of Pangasinan, finds it meritorious to abolish and create a plantilla position in order that the office concerned could deliver more effective and efficient duties and responsibilities;

WHEREAS, the position of Supervising Environmental Management Specialist in the Office of the Provincial Government-Environment and Natural Resources Office (PG-ENRO) is vacant;
