#### **RESOLUTION NO. 45-2024**

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2023 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P5,233,607.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2023 involving total appropriations of P5,233,607.00, which was enacted on October 23, 2023 through Appropriation Ordinance No. 3, Series of 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the said supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- That all procurement to be undertaken shall be subject to the provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Implementing Rules & Regulations; and

3. That the grant of Other Personnel Benefits- (Service Recognition Incentive) to qualified employees for Fiscal Year 2023 shall be in accordance of the provisions of Budget Circular No. 2023-2 dated December 13, 2023.
