RESOLUTION NO. 46-2024

DECLARING MUNICIPAL ORDINANCE NO. 22-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING AND INSTITUTIONALIZING THE PUBLIC EMPLOYMENT SERVICE OFFICE IN THE MUNICIPALITY OF ANDA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 22-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76, 78, 443 (c) (2) & 447 (a) (1) (viii) of R.A. No. 7160; R.A. No. 8759, otherwise known as the “Public Employment Service Office Act of 1999” and R.A. No. 10691 or the “Expanded PESO Law”;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 22-2023 of the Sangguniang Bayan of Anda, Pangasinan, entitled “An Ordinance creating and institutionalizing the Public Employment Service Office in the Municipality of Anda, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
