RESOLUTION NO. 47-2024

APPROVING RESOLUTION NO. 2023-149 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 CY 2023, AS EMBODIED IN THE MDC RESOLUTION NUMBER 2 SERIES OF 2023 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2023-149 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bolinao, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.2 CY 2023. This was endorsed to the Sangguniang Bayan on September 28, 2023 through MDC Resolution No. 2, Series of 2023;
2. Said SIP No. 2 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and the implementation of development projects of the LGU;

3. Also included is the Construction of Two-Storey Public Market in Brgy. Germinal amounting to Php300,000,000.00, which will be funded from the LGU's loan proceeds from Land Bank of the Philippines; and
4. Funding support for the proposed SIP, with a total investment requirement of Php351,536,695.00 is embodied in the municipality's Supplemental Budget No. 2 CY 2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-02 on October 5, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bolinao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-149 of the Sangguniang Bayan of Bolinao, Pangasinan, entitled “To Adopt the Details of the Supplemental Investment Program No. 2 CY 2023, as Embodied in the MDC Resolution Number 2, Series of 2023 of the Municipal Development Council of Bolinao, Pangasinan”;
