RESOLUTION NO. 48-2024

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P351,536,695.00, OPERATIVE IN PART

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of P351,536,695.00, which was enacted on October 5, 2023 through Appropriation Ordinance No. 2023-02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993:

- 2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual Investment Program of the municipality & supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
- 3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
- 4. That the disbursement of Service Recognition Incentive (SRI) to regular & casual employees for FY 2023 shall be subject to specific guidelines to be issued by proper authority granting the same; and
- 5. That the projects covered shall be consistent with/in accordance with the loan agreement between the municipality of Bolinao and the Land Bank of the Philippines.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was-

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Part the Supplemental Budget No. 2 for Calendar Year 2023 of Bolinao, Pangasinan, except the appropriation for the Special Education Fund which is not in accordance with Section 100 (b) of R.A No. 7160;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bolinao, Pangasinan, for its information and guidance.
