RESOLUTION NO. 49-2024

DECLARING ORDINANCE NO. 2023-04 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A GIANT CLAM RESERVES WITHIN THE MUNICIPAL WATERS OF BOLINAO, PANGASINAN PROVIDING RULES AND REGULATIONS AND PENALTY FOR VIOLATION THEREOF AND OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2023-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (i), & 447 (a) (1) (vi) of R. A. No. 7160; and Section 16 of R.A. No. 8550 or commonly known as “An Act Providing for the Development, Management and Conservation of the Fisheries and Aquatic Resources, Integrating all Laws Pertinent Thereto, and for Other Purposes”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Section 59 (a) & (c) of R.A. No. 7160;
