RESOLUTION NO. 57-2024

APPROVING SB RESOLUTION NO. 123, S-2023 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING RESOLUTION NO. 7 SERIES OF 2023 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, PANGASINAN ENTITLED "RESOLUTION ENDORSING REVISED ANNUAL INVESTMENT PROGRAM 2023 OF CALASIAO, PANGASINAN FOR CALENDAR YEAR 2023"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 123, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan has prepared the municipality's Revised Annual Investment Program for CY 2023. This was endorsed by the Council, through MDC Resolution No. 7, Series of 2023 dated September 6, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991; and
2. The LGU revised their AIP for CY 2023 to include new projects proposed to be funded from their Unexpended Balance of Municipal Disaster Risk Reduction and Management (LDRRM) Fund CY 2022 amounting to P4,599,621.09, which emanated from the MDRRM Council and approved

thru MDRRM Council Resolution No. 4, Series of 2023 dated September 6, 2023. This is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote: “The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.”


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


