RESOLUTION NO. 60-2024

DECLARING MUNICIPAL ORDINANCE NO. 003-2023 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE POSITION OF SUPERVISING ADMINISTRATIVE OFFICER (HRMO IV) AND THEREBY CREATING THE POSITION OF THE FOLLOWING: 1.OFFICE OF THE HRMO-ADMINISTRATIVE OFFICER I (HRMO I) SG-11, 2. OFFICE OF THE HRMO-ADMINISTRATIVE ASSISTANT II (AUDIO VISUAL AIDE TECHNICIAN II) SG-8, 3. OFFICE OF THE HRMO-ADMINISTRATIVE AIDE III (UTILITY WORKER II) SG-3” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 003-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, the Local Chief Executive shall, in coordination with the Municipal Local Finance Committee provide an appropriation for the implementation of the subject ordinance;


