**RESOLUTION NO. 63-2024**

**DECLARING ORDINANCE NO. 2, S-2023 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “RENAMING AMBALANGAN DALIN ELEMENTARY SCHOOL TO ALEJANDRO S. BANDARLIPE ELEMENTARY SCHOOL, AS A WAY OF GIVING HONOR AND EXPRESSING PROFOUND GRATITUDE TO THE DONOR OF THE LOT WHERE THE SAID SCHOOL WAS SITUATED” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 2-S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 13 (c) (1) (2) (3) (4) (5) (d) & (h) of R. A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2-S-2023 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled “Renaming Ambalangan Dalin Elementary School to Alejandro S. Bandarlipe Elementary School, as a way of giving honor and expressing profound gratitude to the donor of the lot where the said school was situated” as within the conferred powers of the Sangguniang Bayan to enact;
