## **RESOLUTION NO. 63-2024**

DECLARING ORDINANCE NO. 2, S-2023 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "RENAMING AMBALANGAN DALIN ELEMENTARY SCHOOL TO ALEJANDRO S. BANDARLIPE ELEMENTARY SCHOOL, AS A WAY OF GIVING HONOR AND EXPRESSING PROFOUND GRATITUDE TO THE DONOR OF THE LOT WHERE THE SAID SCHOOL WAS SITUATED" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
