**APPROVING RESOLUTION NO. 2023-211 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 FOR CY 2023 OF THE MUNICIPALITY OF ALCALA, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2023-211 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their Supplemental Annual Investment Program No. 02 (SIP-02) This was endorsed to the Sangguniang Bayan for approval on November 6, 2023 by the Municipal Development Council thru Executive Committee MDC Resolution No. 2023-01;
2. Said SIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive and Performance Based Bonus to qualified LGU officials and employees and other Personnel Benefits) and MOOE for the payment of Environmental / Sanitary Services with the total investment requirement of Php 2,763,972.50; and

3. Funding support for the full implementation of the same is embodied in their Supplemental Budget No.02 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-02 dated November 20, 2023.


