RESOLUTION NO. 68-2024

DECLARING ORDINANCE NO. 7, S-2023 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE PERMANENT POSITION FOR PLANNING OFFICER II IN THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR, MUNICIPALITY OF BAUTISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Municipal Ordinance No. 7, S. of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 7, S. of 2023 of the Sangguniang Bayan of Bautista, Pangasinan, entitled “An Ordinance Creating the Permanent Position for Planning Officer II in the Office of the Municipal Planning and Development Coordinator, Municipality of Bautista, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
