**APPROVING RESOLUTION NO. 107, S-2023 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02, SERIES 2023 (SIP-02-SS-2023) OF THE MUNICIPALITY OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2023"**

**WHEREAS**, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 107, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sto. Tomas, Pangasinan has identified items in their Supplemental Investment Program (SIP -02-SS-2023) This was endorsed to the Sangguniang Bayan for approval on October 24, 2023 by the Municipal Development Council thru Executive Committee MDC Resolution No. 02-SS-2023;
2. Said SIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive and Performance Based Bonus to qualified LGU officials and employees and other Personnel Benefits) with the total investment requirement of Php 4,308,399.60; and

3. Funding support for the full implementation of the same is embodied in their Supplemental Budget No.02 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02 Series 2023 dated November 14, 2023.
