#### **RESOLUTION NO. 74-2024**

DECLARING THE SUPPLEMENTAL BUDGET NO. 02, FOR CALENDAR YEAR 2023 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF Php4,308,399.60, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2023 involving total appropriations of P4,308,399.60, which was enacted on November 14, 2023 through Appropriation Ordinance No. 02, Series of 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

- 3. That the grant of Productivity Enhancement Incentive (PEI) shall be subject to the provisions of Budget Circular No. 2017-4 of Department of Budget and Management dated December 4, 2017;
- 4. That the grant of Performance-Based Bonus (PBB) for Calendar Year 2022 to qualified municipal officials and employees shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2022-1 dated March 24, 2022; and
- 5. That the appropriation for Other Personnel Benefits for Fiscal Year 2023 shall be disbursed only upon issuance of a circular granting the same.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Its Entirety the Supplemental Budget No. 02 for Calendar Year 2023 of Sto. Tomas, Pangasinan;
