DECLARING MUNICIPAL ORDINANCE NO. 03, S-2023 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING THE PETITION FOR FARE HIKE OF UNITED TRICYCLE OWNERS AND DRIVERS ASSOCIATION OF STO. TOMAS, PANGASINAN, INCORPORATED (UTODASTPI) IN THE MUNICIPALITY OF STO. TOMAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
