RESOLUTION NO. 76-2024

DECLARING MUNICIPAL ORDINANCE NO. 189-220823 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PHILIPPINE PACKAGE OF ESSENTIAL NON-COMMUNICABLE DISEASES (NCDs) INTERVENTIONS (PHILPEN) ON THE INTEGRATED MANAGEMENT OF HYPERTENSION AND DIABETES FOR PRIMARY HEALTH CARE FACILITIES IN THE MUNICIPALITY OF VILLASIS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 189-220823 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Department of Health Administrative Order 2012-0029, otherwise known as "Implementing Guidelines on the Institutionalization of Philippine Package of Essential NCD Interventions (Phil Pen) on the Integrated Management of Hypertension and Diabetes for Primary Health Care Facilities"; and Sections 17 (a) (b) (2) (iii) & 447 (a) (2) & (i) of R. A. No. 7160";

WHEREAS, the Municipality of Villasis should explicitly provide the specific allocation for the implementation of the subject ordinance so as not to affect the allocation already appropriated to specific programs expenditures of the LGU;
