RESOLUTION NO. 79-2024

DECLARING MUNICIPAL ORDINANCE NO. 12-2023 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING PARCELS OF LAND COVERING A TOTAL AREA OF EIGHTY FOUR-THOUSAND THREE HUNDRED SIXTY-ONE (84,361) SQUARE METERS LOCATED AT BARANGAY PALAKIPAK, ROSALES, PANGASINAN, FROM AGRICULTURAL TO COMMERCIAL/INSTITUTIONAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Municipal Ordinance No. 12-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Provincial Planning and Development Coordinator have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the requisite of public hearing has been complied with wherein concerned barangay officials and residents posed no objection on the proposed establishments of a Memorial Park which is the subject land for reclassification;

WHEREAS, the Municipality of Rosales has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY-2017-2026;

WHEREAS, the Sangguniang Bayan submitted its Resolution No. 176-2023, resolution proposing the reclassification of parcels of land covering a total area of eighty-four thousand three hundred sixty one (84,361) square meters located at Barangay Palakipak, Rosales, Pangasinan from agricultural to commercial/institutional use;

WHEREAS, subject ordinance shall take effect after the Clearance for Reclassification (Certification) from the Department of Agriculture is submitted to the Sangguniang Panlalawigan, since only the Certification from the Department of Agrarian Reform have been submitted;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 12-2023 of the Sangguniang Bayan of Rosales, Pangasinan, entitled “An Ordinance Reclassifying Parcels of Land Covering a Total Area of Eighty Four-Thousand Three Hundred Sixty-One (84,361) Square Meters Located at Barangay Palakipak, Rosales, Pangasinan, from Agricultural to Commercial/Institutional Use” as within the conferred powers of the Sangguniang Bayan to enact;
