#### PROVINCIAL RESOLUTION NO. 81-2024

SUPPORTING THE INVENTORY OF ALL REAL PROPERTIES OWNED AND LEASED OUT BY THE PROVINCIAL GOVERNMENT OF PANGASINAN SUCH AS BUT NOT LIMITED TO INFRASTRUCTURES AND OTHER FACILITIES

WHEREAS, Sec. 524 of R.A. 7160 otherwise known as the Local Government Code of 1991 provides that each local government unit shall conduct a periodic inventory of infrastructure and other community facilities and undertake the maintenance, repair, improvement, or reconstruction of these facilities through a closer cooperation among the various agencies of the National Government operating within the province, city, or municipality concerned;

WHEREAS, Sec. 465 par. (3) of the same Code grants the Chief Executive the power "to initiate and maximize the generation of resources and revenues, and apply the same to the implementation of development plans, program objectives and priorities as provided for under Section 18 of this Code, particularly those resources and revenues programmed for agro-industrial development and country-wide growth and progress and, relative thereto, shall: ...xxx...(vi) Provide efficient and effective property and supply management in the province; and protect the funds, credits, rights, and other properties of the province";

WHEREAS, it is just and proper to conduct the inventory of real properties owned by the provincial government to utilize and maximize the potentials of all real properties of the Provincial Government of Pangasinan suitable for future improvement for the integration of financial management and business operations in the province, to spearhead the growth of infrastructure and to increase the revenue of the Province of Pangasinan;

WHEREAS, the existence of an inventory of real properties owned and leased out by the provincial government of Pangasinan would mark the beginning of extensive reform, and the upcoming development of programs, plans and activities;
