APPROVING SB RESOLUTION NO. 85, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE REALIGNMENT/REVERSION OF ONE MILLION ONE HUNDRED THOUSAND PESOS (P1,100,000.00) FROM THE GENERAL FUND SPECIAL PURPOSE APPROPRIATION PPAs UNDER THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2023, AND FOUR MILLION THREE HUNDRED THOUSAND PESOS (P4,300,000.00) FROM THE MUNICIPAL DEVELOPMENT FUND (MDF) CY 2023, 2022 AND 2019, HAVING A TOTAL AMOUNT OF FIVE MILLION FOUR HUNDRED THOUSAND PESOS (P5,400,000.00) OF THE MUNICIPALITY OF BANI, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 85, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The proposal for alignment/reversion of appropriation for 20% development fund projects in AIP 2022, 2023 and 2019 and for the General Fund Special Purpose Appropriation programs/projects in AIP 2023 to augment funding for the implementation of the priority programs/projects of the LGU, emanated from the Local Development Council and was endorsed to the Sangguniang Bayan through MDC Resolution No. 2023-08 on November 7, 2023; and

2. The development project proposed to be funded from the realigned 20% Development Fund are based on DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


