#### **RESOLUTION NO. 85-2024**

APPROVING SB RESOLUTION NO. 86, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT PROJECTS WORTH OF FOUR MILLION THREE HUNDRED THOUSAND PESOS (P4,300,000.00) FUNDED BY THE REALIGNED MUNICIPAL DEVELOPMENT FUND (MDF) CY 2023, 2022 AND 2019 OF THE MUNICIPALITY OF BANI, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 86, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following finding:

 The proposed municipal development projects (Rehab/Impv't of Bani Public Market and Procurement of Heavy Equipment for sanitary landfill/garbage truck) amounting to PhP4,300,000.00, which will be funded on the same source of fund mentioned in SB Resolution No. 85, S-2023, also emanated from the Local Development Council and was endorsed to the Sangguniang Bayan thru MDC Resolution No. 2023-09 on November 7, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;
