APPROVING SB RESOLUTION NO. 87, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 CY 2023 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO TEN MILLION, FIVE HUNDRED TWENTY THREE THOUSAND, ONE HUNDRED SEVENTY ONE PESOS AND 23/100 CENTAVOS (P10,523,171.23) FUNDED BY THE RETAINED EARNINGS/SURPLUS CY 2022, PERSONAL SERVICES SAVINGS CY 2023, REALIGNED GENERAL FUND-SPAs CY 2023, AND REALIGNED MUNICIPAL DEVELOPMENT FUND (MDF) CY 2023, 2022 AND 2019”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 87, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Supplemental Investment Program (SIP) No. 04 was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval on November 7, 2023 through MDC Resolution No. 2023-10. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

2. The SIP No. 04 covers fund augmentation for Personal Services Maintenance and Other Operating Expenses, Financial Expenses (loan amortization), and Capital Outlay of some municipal offices, and implementation of priority programs/projects of the LGU;
3. Said SIP also includes the Rehab/Impv't of Bani Public Market and Procurement of Heavy Equipment for sanitary landfill/garbage truck amounting to PhP4,300,000.00 to be funded from the realigned CY 2019, 2022 and 2023 municipal development fund and program/projects to be funded from the realigned general fund – special purpose appropriation of AIP CY 2023 (PhP1,100,000.00) which are the subject of SB Resolution Nos. 85 and 86, both Series of 2023; and
4. Funding requirement for the implementation of the said SIP, amounting to PhP10,523,171.23, is embodied in the municipality's Supplemental Budget No. 04 FY 2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04, S-2023 on November 14, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Arthur C. Celeste, Jr., Joyce D. Fernandez and Maria Doriza V. Ramos, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 87, S-2023 of the Sangguniang Bayan of Bani, Pangasinan, entitled “Approving the Supplemental Annual Investment Program No. 04 CY 2023 of the Municipality of Bani, Pangasinan amounting to Ten Million, Five Hundred Twenty Three Thousand, One Hundred Seventy One Pesos and 23/100 Centavos (P10,523,171.23) funded by the Retained Earnings/Surplus CY 2022, Personal Services Savings CY 2023, Realigned General Fund-SPAs CY 2023, and Realigned Municipal Development Fund (MDF) CY 2023, 2022 and 2019”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bani, Pangasinan, for its information and guidance.
