### RESOLUTION NO. 88-2024

**APPROVING RESOLUTION NO. 128, S-2023 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE FOURTH SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 128, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Infanta, Pangasinan has identified items in their Fourth Supplemental Annual Investment Program (SAIP) for CY 2023. This was endorsed to the Sangguniang Bayan on December 1, 2023 through MDC Resolution No. 06, Series 2023;
2. The SAIP No. 04 covers fund augmentation for the Personal Services (granting of SRI and other personnel benefits), Maintenance and Other Operating Expenses, and Capital Outlay of some offices of the LGU; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP15,076,301.44, is embodied in the municipality's Supplemental Budget No. 4 CY 2023, which was approved and enacted by their Sangguniang Bayan on December 4, 2023 through Appropriation Ordinance No. 05, Series of 2023.




