PROVINCIAL RESOLUTION NO. 891-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A RENEWAL OF MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF NATIVIDAD AND THE EASTERN PANGASINAN DISTRICT HOSPITAL FOR THE ADOPTION OF REFERRAL SYSTEM ON NEONATAL SERVICES

WHEREAS, the 1987 Constitution ensures the protection and promotion of the right of the people to health and guarantees the availability of essential health services to all the people at affordable cost through various plans and programs;

WHEREAS, the Eastern Pangasinan District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and areas nearby localities of the 6th District of Pangasinan;

WHEREAS, the Natividad Municipal Health Office and Birthing Clinic of the Local Government Unit of Natividad, Pangasinan does not have complete facilities to provide Newborn Hearing Test services to its patients and wishes that it be provided to them by the Eastern Pangasinan District Hospital;

WHEREAS, the adoption of referral system on said neonatal services between the Eastern Pangasinan District Hospital and the Natividad Municipal Health Office and Birthing Clinic is an important local health program in order to strengthen healthcare services to the Province;

WHEREAS, the program is in consonance to RA 11223 or the Universal Health Care Act of 2019 which mandates the implementation of health reform program in order to ensure that every Filipino is guaranteed an equitable access to quality and affordable healthcare services and is protected against financial risks;

WHEREAS, it is also in conformity with Section 13 of the 1987 Constitution which provides that local government units may group themselves, consolidate or coordinate their efforts, services, and resources for purposes commonly beneficial to them in accordance to the law;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;


WHEREAS, for the above purpose, a renewal of Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Local Government Unit of Natividad, Pangasinan, represented by Municipal Mayor Rosita G. Rafael;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a renewal of Memorandum of Agreement (MOA) between the Local Government Unit of Natividad and the Eastern Pangasinan District Hospital for the adoption of referral system on Neonatal Services;

RESOLVED FINALLY, that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, Municipal Mayor Rosita G. Rafael, Natividad, Pangasinan and Dr. Agnes Leored D. Rioflorida, Chief of Hospital I, Eastern Pangasinan District Hospital, for their information and guidance.
