PROVINCIAL RESOLUTION NO. 896-2024

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO NEGOTIATE WITH THE METRO PANGASINAN HOSPITAL AND MEDICAL CENTER LOCATED IN VILLASIS, PANGASINAN FOR THE POSSIBLE PURCHASE THEREOF

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 and its Implementing Rules and Regulations consistent with the General Welfare Clause, recognizes the need to embark into meaningful efforts to improve the healthcare services and programs in the Province;

WHEREAS, healthcare facilities play a crucial role in assessing the health needs of the constituency and providing the necessary services, equipment and infrastructure to support them;

WHEREAS, the present administration deems it important to give foremost consideration to the augmentation of the services of the fourteen (14) provincial government hospitals of Pangasinan through additional healthcare facilities to provide Pangasinenses greater access to health services at all times;

WHEREAS, the much-needed hospital facility would add to better and accessible ways of serving the people of Pangasinan especially the underprivileged as it would pave the way for more areas to be served;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan, represented by Governor Ramon V. Guico III, to negotiate with the Metro Pangasinan Hospital and Medical Center located in Villasias, Pangasinan for the possible purchase of the said hospital;


