APPROVING RESOLUTION NO. 247, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CY 2024 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 247, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- The Municipal Development Council of Binmaley, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2024. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2024 dated June 26, 2024, to the Sangguniang Bayan for approval;
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱77,886,706.63, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of the LGU, and implementation of development projects of the municipality;

- 3. The projects proposed to be funded from the realigned 20% Development Fund conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects); and
- 4. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 1 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2024 dated June 27, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 247, S-2024 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled "Approving the Supplemental Investment Program No. 2 for CY 2024 of the Municipality of Binmaley, Pangasinan";
