#### **RESOLUTION NO. 899-2024**

DECLARING MUNICIPAL ORDINANCE NO. 4, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE PARCEL OF LAND LOCATED IN BARANGAY BAYBAY LOPEZ, BINMALEY, PANGASINAN, TO BE USED AS MEMORIAL PARK BY MT. ZION MEMORIAL INCORPORATED FROM ECO-TOURISM AND AGRICULTURAL LAND TO COMMERCIAL PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 4, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Department of Human Settlements and Urban Development have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 20 (a) (2) (3) (c) (d) (e) and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Binmaley has an existing and approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2018-2027;

WHEREAS, the Sanguniang Bayan of Binmaley had earlier passed SB No. 150, S-2023, entitled "Resolution Proposing the Reclassification of a Parcel of Land Located in Barangay Baybay Lopez, Binmaley, Pangasinan to be Used as Memorial Park by Mt. Zion Memorial Incorporated.";
