- MOA with the Region 1 Medical Center on zero hospitalization fees for PNP Personnel with serious illnesses and availability of blood supply through regular bloodletting activities;
- The construction and operationalization of the Tanglaw-Lahi '99 Early Childhood Day Care and Development Center;
- The launching of the Police Express to facilitate quick response to the community providing them adequate assistance;
- Pangasinan, having been declared an Insurgency-Free Province since 2020, is being sustained through the conduct of OPLAN PANAGSUBLI;

WHEREAS, under his inspired stewardship, the Pangasinan Police Provincial Office collectively promoted good relations with, and respect for civilian authority, as evidenced by the strong ties established between the leaders and the people of Pangasinan and the Philippine National Police;

WHEREAS, under his tutelage, the Pangasinan Police Provincial Office has also actively participated in and strongly supported the various activities being undertaken by the Provincial Government of Pangasinan;

WHEREAS, last October 1, 2024, a Turn-Over of Command Ceremony was held signaling a change in the command and leadership of the Pangasinan Police Provincial Office, from Police Colonel Jeff E Fanged to Police Colonel Rollyfer J Capoquian;


